Marsha researched cost effective options for implementing google ads, coordinated with the webmaster to obtain needed information about the website and drafted a proposal that the committee submitted to the IG Board for review and feedback.

Mollie continued to be in contact with the organizers of the Black Vegfest to finalize all the day-of logistics.
