**Welcome Committee Report/Sasha H:** On Unity Day the welcoming committee held meetings which focused on Unity with Diversity and helping fellows understand how to be more supportive of others. The event had about 25 fellows at its peak and was the first event the committee has put together. We read the full Unity with Diversity policy and the mission statement of the committee, read the welcoming survey result and gave insight into the kind of work the committee does. The workshop was followed by a literature meeting that focused on the pamphlet Black members share their experience, strength and hope. There were fellows who seemed to be intimidated by talking about race in the context of the program in fact about 15 fellows left the workshop within 5 minutes of attending. For those who stayed we worked together to expand the minds of hearts of fellows in such a way that they can be more purposeful in extending a heart and had to a more diverse group who share our compulsion.

The World service Unity with Diversity committee used our survey results on Unit Day to talk more openly to fellows about diversity in OA. They reported that it was well received. Other regions and intergroups are forming similar committees similar to the welcoming and are using the quizzes, surveys and committee model to talk about diversity in their respective cities.

At our next meeting we will discuss how to make these difficult discussions more exciting, appealing and informative to fellows. We will also talk about creating virtual literature as other groups are using the oanyc web page as a source. **Bylaws Committee Report/Rebecca B:** We have been asked to work on a draft amendment that would incorporate the Welcoming Committee into the By-laws, consistent with other Committees, to submit for the approval process as outlined. It will be ready for initial review shortly, then we will follow the steps for consideration as outlined in the By-laws.

**Publications Committee Report/Hannah P:** Publications sent out the February Metro Memo on Friday, February 12. The click rate was 28%. Publications also sent out a blast for the Unity Day Marathon on Thursday, February 25. The click rate was 33%. This is along the lines of what we have seen in the past. We will send out the story-based March Metro Memo on Friday, March 12. After that, we will prepare the email memo for April. Publications will also continue to send out blasts. **Special Events Committee Report/Sasha:** On Unit day we partnered with the welcoming committee and held a workshop and meeting that themed around Unity with Diversity. At the peak of both events there were about 15 fellows. Although a smaller event it was qualitatively impactful. One event was a workshop based on the welcoming quiz and made skits about how to be more supportive of fellow students and what's an appropriate way to make fellows feel welcome. The second was meeting with transgender speakers sharing their experience strength and hope on unity and diversity in program. The event was well received and many of the fellows who attended stayed for the entirety of the 4 hour event. Fellows were thankful and many left feeling they learned how to be more loving and understanding and recognize the complexities of the lack of diversity in the rooms of OA. No funds have been reported to have been collected at the event.
